

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.drleehousecalls.com, and Dr. Lee House Calls and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Dr. Lee House Calls include www.drleehousecalls.com and Dr. Lee House Calls. The Dr. Lee House Calls website is a House Call Chiropractic site. By using the Dr. Lee House Calls website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Dr. Lee House Calls may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase Dr. Lee House Calls's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Dr. Lee House Calls collects and uses your personal information to operate and deliver the services you have requested.

Dr. Lee House Calls may also use your personally identifiable information to inform you of other products or services available from Dr. Lee House Calls and its affiliates.

Sharing Information with Third Parties

Dr. Lee House Calls does not sell, rent or lease its customer lists to third parties.

Dr. Lee House Calls may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Dr. Lee House Calls may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Dr. Lee House Calls, and they are required to maintain the confidentiality of your information.

Dr. Lee House Calls may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Dr. Lee House Calls or the site; (b) protect and defend the rights or property of Dr. Lee House Calls; and/or (c) act under exigent circumstances to protect the personal safety of users of Dr. Lee House Calls, or the public.

Opt-Out of Disclosure of Personal Information to Third Parties

- The categories of personal information that we disclosed about you for a business purpose.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Dr. Lee House Calls. Use of Cookies

Right to Deletion

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
